## RESOLUTION No. 2024-02

**WHEREAS,** Representative Stacey Hobgood-Wilkes, in her official capacity as a State Representative, has demonstrated exceptional dedication and commitment to the principles of justice and the protection of state laws; and

**WHEREAS,** on the evening of September 9, 2024, Representative Hobgood-Wilkes traveled to Grenada, Mississippi, to address the City Council regarding a violation of the Mississippi Monument Protection Law specifically concerning a Confederate monument; and

**WHEREAS**, during her address, Representative Hobgood-Wilkes poignantly stated that the Confederate monument serves as a headstone for those who did not return and whose final resting places are known only to God; and

**WHEREAS**, her actions have highlighted the importance of upholding the state's legal standards and have contributed to the broader protection and respect for historical and cultural landmarks within the state of Mississippi; and

**WHEREAS**, the efforts of Representative Hobgood-Wilkes reflect great credit upon herself and the principles of public service, and serve as an inspiring example of effective legislative advocacy and civic responsibility;

**BE IT HEREBY RESOLVED**, that the Gainesville Volunteers, Sons of Confederate Veterans Camp No. 373 formally commends Representative Stacey Hobgood-Wilkes in her official capacity for addressing the City Council of Grenada, Mississippi, and remaining steadfast when Mississippi's Confederate heritage is under attack.
